Authorization

- To the best of my/our knowledge, the Registration Form that I/we provided is correct and complete.
- I/we declare that _____ is permitted to engage in all camp activities except as noted.
- I/we understand that in the case of a medical emergency, the staff at The Greenwoods Academy will make every effort to contact me/us or the person(s) listed as the emergency contact(s). In the event that I/we or the emergency contact(s) cannot be reached, I/we give permission to the staff selected by The Greenwoods Academy to arrange transportation to local medical facilities.
- In the event of an emergency, and The Greenwoods Academy is unable to contact me/us, the listed emergency contact(s), or the camper's physician, I/we grant permission to the physician(s) selected by The Greenwoods Academy to perform any treatment they deem medically necessary.
- I/we understand that I/we are responsible for all medical costs incurred in treating our child.
- I/we authorize the camp director to use his/her discretion in administering medications as indicated.
- I/we agree that the laws of the Province of Ontario shall govern this waiver and release.
- I/we affirm that I/we have read and understand this document.

Release

- I/we have read The Greenwoods Academy Summer Camp information and understand the nature of the activities and the health and safety measures undertaken by the Camp. By signing this contract, I/we give permission to my/our child to participate in planned activities, to use the facilities in connection with these activities, and to take part in off-campus trips. By signing this contract I/we agree for myself/ourselves and my/our child to release and hold harmless The Greenwoods Academy and all of its affiliates, including Greenwoods Academy, officers, agents and employees from all claims, actions, causes of action, liability, loss, damage, controversies, accidents and injuries, and any expense, which in any way may arise from my child's participation in the Greenwoods Academy Summer Camp and/or through any act of omission of The Greenwoods Academy or any of its officers, agents, or employees. This General Release is intended to include any claim which my/our child may have arising from personal injuries or other accidents and injuries caused by another child or other participant in Camp activities. Additionally by signing this contract I/we agree to indemnify and hold harmless The Greenwoods Academy for any claims accidents and injuries which are caused by my/our child.
- I/we give permission for my child to be photographed/videotaped and for the Camp to use the pictures for publicity purposes.
- I further understand and agree that Greenwoods Academy is not obligated to refund tuition for any applicant or participant who withdraws for any reason, including illness or injury. Any deposit is not refundable and not transferable. No refund or reduction in fees is possible for a child who arrives late, leaves early, or attends only part of a session.
- I/we agree to pay the balance of the Camp fees on or before May 1 2012. I/we understand the Camp cannot guarantee a spot for my/our child if the payment is not received by May 1 2012.
- I/we understand that it is my/our responsibility to bring any special concerns about my child to the Camp Director's attention at the time of registration.
- I/we understand that Camp will be closed for all Ontario statutory holidays.
- I/we understand that the camp administration reserves the right to dismiss a camper when in his/her judgement the camper's behaviour interferes with the rights of others, the functioning of the group or activity or violates the camp's principles of conduct. In such cases no refunds will be given.
- I/we have read and reviewed carefully the camp information provided and also the terms of this contract. By signing below I/we understand this document constitutes a legally binding contract, to be construed under the Province of Ontario law and under which both parties agree to be bound.
- I/we understand that no camper will be registered unless a completed registration form, health history form, and this form accompanies the deposit.
- I/we understand that my child may not attend Camp if the immunization record and health information is not received before the start of Camp. I/we understand that The Greenwoods Academy Summer Camp recommends that each camper have a physical examination within 12 months of attending camp.
